Entry requirements

Anyone qualified to be admitted to a third-cycle programme in work-integrated learning or the equivalent can be admitted to this course

The forms of assessment of student performance Module I

Third-cycle students are examined when on an individual basis they, orally and in writing, account for and critique results and analysis of course content as well as when they in a final, individually composed assignment relate this to their own dissertation. (5 HE credits)

Module II

Students are examined when they do two assignments:

The first assignment requires the student to account for results of a literature search limited to the theme of the course (knowledge and learning with a focus on WIL), and to do so individually, both orally and in writing, and to connect this to the research field of their own dissertation. (2.5 HE credits)

The second assignment requires third-cycle students, working in small groups, to do both oral and written presentations of a synthesis of the group members' individual literature searches from their different research fields. The written paper should result in one text, composed in a scholarly format by the group, and one individual reflection task. (2.5 HE credits)

Module III

Students are examined when they do two assignments:

The first assignment requires each individual third-cycle student orally and in writing to account for a compilation and analysis of WIL research in a specific context/organisation. (2.5 HE credits)

The second assignment is done in small groups where a synthesis of the individual papers, each coming from a specific context, is compiled. This should result in a short scholarly text. (2.5 HE credits)

Course contents

This course falls under the category of work-integrated learning in both content and structure. Relevant parts of the content should, if possible, be integrated into the third-cycle student's own dissertation work.
