Entry requirements

BA/BSc in education or nursing, 180 credits, or Bachelor's degree, 180 credits with a major in social work and social pedagogy, psychology, pedagogics, sociology, culture studies or public health or the equivalent, and the equivalent of English studies at the upper secondary (high school) level in Sweden, called English 6 or English B.

Knowledge and understanding

Upon completion of the programme, the student should be able to:

- show in-depth knowledge of Child and Youth Studies as an interdisciplinary research domain,
- show knowledge of how childhood and adolescence are viewed differently, depending on society, social group, and times,

- show awareness of and be able to deal with the specific methodological and ethical issues associated with research involving children and adolescents.
